### **Special Meeting Interviews**

At the Special Council meeting, the following shall take place:

- a) Notwithstanding the requirements of the Procedural By-law, the agenda for the meeting shall be set by the Clerk to allow for the orderly proceeding of selecting a candidate.
- b) The Mayor will make a short statement of the purpose of the meeting and the general order of proceedings to be followed.
- c) The Clerk will provide to the Mayor a list of the names of those individuals who have indicated, in writing, their interest in being appointed to the vacancy and the Mayor will call for a motion from Council in the following form:
  - "THAT the following individuals, who have signified in writing that they are legally qualified to hold office and consented to accept the office if they are appointed to fill the vacancy, be considered for appointment to fill such vacancy."
- d) All candidates will be sequestered in an adjacent room (or their vehicles) until it is their time to answer the questions posed by Council.
- e) Each of the candidates shall be afforded the opportunity to address Council for a period of not more than ten (10) minutes. The order of speaking will be determined by lot. The Clerk shall place the names of all nominees in a container and randomly draw the names.

### Note: Candidates will be timed.

f) Each member of Council will be permitted two (2) questions to each candidate. Candidates have two (2) minutes to answer each question. Once a candidate has answered the questions, they will return to the sequester room.

#### Note: Candidates will be timed.

g) Upon hearing all the submissions of the candidates, Council will proceed to rank the candidate in order of preference. Each Councillor is to rank each candidate using a sample ballot attached. Scores will be given to the candidates based on ranking. I.e. 4 points are given for appearing in first ranking. 3 points to a second rank position and on down to 5<sup>th</sup> place receiving no points. The ballots are to be marked by the individual Council members and the points will be tallied by the Clerk. Ballots will not be revealed only the final results. In the event of a tie between points allotted to a candidate for most points received, a second round of voting will occur using only the candidates that are tied. All other candidates will be dismissed and removed from the process. After the second round of voting if there is still a tie in points allotted to a candidate, the Clerk will determine the successful candidate using a draw by lot method. The Clerk shall place the names of the tied candidates in a container and randomly draw one name who will then be determined to be the successful candidate.

### Appointment

The appointment of the candidate shall be made by by-law at the conclusion of the special meeting. A by-law confirming the appointment shall be enacted by Council and shall direct the

## Clerk how to proceed further.

### Oath of Office

The Clerk will administer the Declaration of Office required by subsection 232(1) of the Act at the regular meeting scheduled for February 3, 2021 at 10:00 a.m.

### **Additional Notes**

Where a situation occurs that is not otherwise accounted for in these procedures, the Clerk shall recommend an alternate process to Council, which Council may adopt by simple majority vote.

Good Afternoon Mayor, Deputy Mayor and councillors. I wish to apply for the position of Council.

I graduated from Humber College in 1989 with a Law Clerk Degree. I have worked for lawyers for over 40 years in all facets of law with the last 30 plus years for an Orangeville lawyer. I approached Council with respect to putting a barrier along the Grand River where the horrible accident occurred in order to hopefully circumvent any other tragedy.
